**CAL GRANT TRANSFER ENTITLEMENT VERIFICATION**

The California Student Aid Commission (CSAC) requires verification that you have met the eligibility requirements prior to disbursement of your Cal Grant. **Read each section carefully** and attach all required documents to this form.

**Section 1**

Proof of graduation from a California high school or high school graduation equivalency after **June 30, 2002**. The document **must** include your date of graduation or completion.

- o Acceptable documentation includes one of the following:
  - ✓ Official or unofficial high school transcript (with your graduation date listed)
  - ✓ High school diploma
  - ✓ High school graduation equivalency test results

**Section 2**

Proof of California residency at the time of your high school graduation or its equivalent

- o **If you were 18 years old or older**, you **must** provide proof of California residency for **yourself**
  - Acceptable documentation includes:
    - ✓ A California high school transcript showing attendance at least 1 year prior to graduation
    - ✓ If you do not have a high school transcript, use the list below but for yourself
- o **If you were 17 years old or younger**, you **must** provide proof of California residency for **your parent or legal guardian** for the **calendar year immediately prior to your high school graduation** or its equivalent (for example, if you graduated in 2019, proof of residency in 2018 is needed).
- o Acceptable documentation includes:
  - ✓ A copy of your parent's or legal guardian's **California state** tax return (Form 540)
  - ✓ California lease or rental agreement
  - ✓ California utility bill
  - ✓ California voter registration
  - ✓ California auto registration
  - ✓ California bank account records
  - ✓ Copy of military records verifying relocation orders from California dated prior to your high school graduation or its equivalent **AND** at least one of the documents listed above for a period that predates the relocation orders
